CALL FOR PAPERS

The economic take-off is the third stage of the Stages of Economic Growth Theory of Rostow. Through it, a country can avoid the obstacles and barriers that prevent the achievement of economic growth. When the resisting forces of progress are weakened, the average per capita income begins to increase, carrying with it radical changes in the economic and social structure. This is embodied by a combination of factors, most notably, the use of the national stock of competencies, which is characterized by genius, and the power of creativity and the ability to embody ideas and transfer them into real applied models.

Algeria has been searching, for decades, to reach the stage of an economic take-off by escaping from the cocoon of the "Economic Rent", in light of the exceptional knowledge and technology changes that the world is witnessing. The national competencies remain, as well as the highly qualified institutions, good governance, and community participation, the substantiality factors to achieve this take-off. In addition, the process of achieving an acceptable level of growth remains organically linked to the availability of all these factors. Particularly, the national competencies of both its types: Local competencies and those abroad as well. Especially, since there were several cases that were able to succeed in achieving their economic take-off through their national competencies, by providing several objective conditions to embody the role of these competencies. Based on the previous proposal, the problem arises as follows: What are the ways to invest in national competencies and enhance their role in achieving the economic take-off?

- ♣ The manuscript should be on the topic of the conference and one of its themes.

- ♣ The manuscript preparation should follow the scientific research methodology.
- 4 All manuscripts will be peer-reviewed by reviewers who are experts in their field.
- → The number of the manuscript's pages must not exceed 20 pages, including references and appendices.
- **♣** The full text of the manuscript shall be written according to the following conditions:
 - ❖ The first page includes the author's information (name and surname, e-mail, occupation, institution), the title of the manuscript and the theme of research, and an abstract not exceeding 300 words that includes the research objective, research problem, the main results, and the key words.
 - ❖ The manuscripts which are written in Arabic shall be in (Sakkal Majalla) font size 16 and the manuscripts are written in the foreign language shall be written in (Times New Roman) font size 12 and with a space between lines (Single). The page margins are set as follows: 2.5 cm to the right of the page, 2 cm on the left, and the top and bottom of the page as well.
 - * Titles and subtitles are written in bold.
 - ❖ Should follow the APA style for writing references.

- ✓ Deadline for submission of full papers: March 20th, 2023.
- ✓ All participants will be answered with acceptance or rejection for their manuscripts within thr period from March 25 to 31st, 2023.
